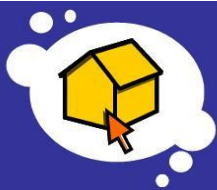

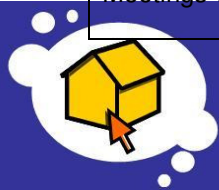

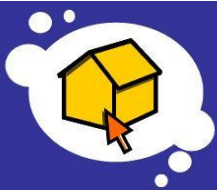
# Social Housing Forum
